On June 14th 2022 the District Wellness Committee completed the SY22 assessment of the District Local Wellness Policy and Plan.

The following are the results of the assessment:

- The District's Policy and Plan meet all of the USDA and ADE regulations for Food Service, Health and Wellness, and Physical Activity.
- The District's Foodservice Department continues to make strives to ensure healthy and delicious food options for students across the district.
- The District is following and exceeding its LWP in the area of Physical Activity.
- The District has implemented nutrition education with the Roaming Chef Program and the FFVP program at Laguna and Walter Douglas.
- The Wellness Committee will continue to look at how the LWP can increase healthy alternatives at fundraisers in the District
- The Wellness Committee will continue to work with Student Health Advisory Council's to increase awareness of the LWP at sites
- The Wellness Committee will work with its stakeholders to continue to gain feedback on how to better the LWP.
