WENDY NOGAMI EARNS NATIONAL BOARD CERTIFICATION

Congratulations to FWJH English teacher Wendy Nogami for earning her National Board Certification! This remarkable accomplishment requires an extraordinary amount of hard work and dedication over an extended period of time. Only 112,000 (about 3%) of teachers nationwide are National Board certified. This rigorous process requires teachers to demonstrate standards-based evidence of the positive effect they have on student learning. They must exhibit a deep understanding of their students, content knowledge, use of data and assessments and teaching practice. They must also show that they participate in learning communities and provide evidence of ongoing reflection and continuous learning. The Flowing Wells School District now has 14 National Board Certified teachers with even more working toward this great achievement!

CHANGES IN TAX LAW RESULT IN NEW TAX TABLES

Due to recent changes in federal tax law, the IRS has issued new withholding tax tables. Your January 21st paycheck will be processed using the new tax table. As a result of this change, there will be a difference in your Federal income tax withholding amount. If you wish to modify your federal withholding, you must submit a new W4 form to Fran Bond in payroll. The new W4 form is not yet available in ESS, but the forms are available online at irs.gov or in the Business Office.
