

#### Flowing Wells Community Schools Welcome to FWCS Summer YES 2024!

The Summer YES Programs operate from Tuesday- May 28 to Tuesday- July 30, 2024, Monday to Friday from **6:30 a.m. to 6:30 p.m.** at the **Hendricks YES site**, located at 3400 W. Orange Grove Rd, and Monday to Friday from **6:30 a.m. to 6:00 p.m.** at the **Homer Davis YES site**, located at 4250 N. Romero Rd.

**To Register:** Complete the Registration form and Parent Agreement form. Return them to any YES sites or to the Flowing Wells Community Schools office at 5001 N Shannon Rd., Tucson AZ, 85705. Registration is limited to the first 60 students at Hendricks YES and first 40 students at Davis YES. Registration fee is \$25.00 per student and will be billed to your students PowerSchool account. The hourly fee is \$4.20 per hour per child, minimum 1 hour charge. All fees are non-refundable. Your child/children MUST attend a minimum of 3 days per week.

\**Please note:* A \$25.00 non-attendance fee will apply if your child/children does not attend a minimum of 3 days per week. After 2 weeks of non attendance, your child/children may be dropped from the program.
