## PROP 202 AND ONE-TIME ONLY PROP 301 COMPENSATION

The first half of Proposition 202 compensation and the first half of the one-time only Proposition 301 compensation will be distributed to certified teachers in the December 7th paycheck. The Proposition 202 distribution will be \$165. Funding for Proposition 202, the Indian Gaming and Self-Reliance Act, is based on state gaming revenue. Only certified teachers are eligible to receive these funds which are distributed in December and May. The one-time only Proposition 301 amount is half of the amount listed in the contract of the certified employee. Contact the Business Office with questions.

## BCBS TELEMEDICINE FEE WAIVER ENDING

An update for any Flowing Wells employees who access Blue Cross Blue Shield telemedicine services: Beginning on Monday, November 15th, Blue Cross Blue Shield will discontinue its COVID-related cost share fee waiver for telemedicine. On the 15th, cost shares for health plan benefits will return to standard coverage terms, except for items related to COVID-19 testing and vaccinations. COVID-19 diagnostic and antibody testing will remain a covered benefit with a \$0 cost share. Contact Elaine Kimbler with questions.
