Please note: Next week, all SPARs and work agreements will list your current year compensation. However, once the state budget is finalized and we are able to determine raises for next year, you will receive a new SPAR that will indicate your actual compensation details. This new SPAR will likely be issued over the summer.

OPEN ENROLLMENT STARTS MONDAY! We will use email to make open enrollment changes. If you do not want any changes to your benefits, please email Elaine Kimbler a simple "No changes." Once Elaine receives your email, you will be re-enrolled in your current selections. If you do want to make changes, email Elaine for the necessary forms. Open Enrollment will start May 2nd and end May 13th with changes taking effect July 1, 2022. Please remember that after the Open Enrollment period closes, you will not be able to make changes unless there is a Qualifying Event. The one exception to our passive open enrollment is the Flexible Spending Account (FSA). For the FSA, you are required to re-enroll and will be sent an email with instructions.
